 - Question arose as to what, if anything, folks are suppose to do with the information, again it was reiterated it was for informational purposes.
 - Discussion arose that maybe there was a location in the shared drive or website that the inform could be posted so that those who want to know the information can access it without sending out an email.
- C. HB 102 update for campus
 - There is a STAY of execution on the Legislative ruling and Campuses are operating under the old policy at this time.
 - No MUSFAR update on this topic.
- D. Syllabus review including Diversity statement.
 - Diversity statement will be handed over to DEI Team and whenever there is a new syllabus form, the most recent Diversity Statement from DEI will be included.
- E. Building hours on weekends
 - Jana has heard from constituents, and requested that, in the future, Faculty Senate be consulted and collaborated in regards to such decisions.

 - A lot of the policies are actually procedures and will be labeled as such and removed from the GFC Policies. Others are simple changes to names (replace COT or Vo-Tech with GFC) or department positions within the document, those will be revised without discussion.
 - Policies that may be deemed antiquated or simply outdated will be reviewed in further detail.

VI. Standing Discussion Items

- A. MSUFAR update Jana
 - Masking & Vaccination lot of discussion, especially from the smaller campuses on the timeliness, or lack there of, of distribution of information.
 - Biggest concern keeping campuses open and with minimal disruption of classes.
 - Billings being the hotspot of Covid is very concerned and has numerous disruptions.
 - MUSFAR has drafted a letter to send to OCHE/BOR with their concerns.
 - Best way to describe not being able to make decisions for our campuses "a bit of a pickle"
- B. Policy Reviews Stacy and Carmen
 - 161 policies over the next 3 years. The policies will then be put on a regular revolving schedule for review so as not to have this volume all at once in the future.
 - Faculty Senate and Staff Senate will be voting on policies. If the changes don't pass, they will go back for review.
 - There will be 8 rounds of policy revision this year.
