## **Standing Items**

1. Healthy Campus Task Force Presenter: Dr. Frost ET Lead: Dr. Frost

The Plan for a Healthy Campus by the GFC task force is out for review.

Joshua Archey is working to organize a vaccination clinic, if possible before the Town Pump incentive ends on June 20. This deadline may be extended.

2. COVID Calls | Presenter: Ms. Bonilla | ET Lead: Ms. Bonilla

The group is working on coming up with new incentives for students. GFC MSU has given out 5 of the Town Pump gift cards.

3. HEERF Funding Presenter: Ms. Bonilla/Ms. Roberts ET Lead: Ms. Bonilla/Ms. Roberts

**Student Emergency Funding:** \$254,000 has been distributed to 282 summer students. GFC has spent almost \$1.5 million in direct-to-students grants, and an additional \$1.25 million will be distributed. This information will be shared with students via campus news and the website.

**Institutional Funding Distribution:** Projects under consideration for HEERF funding include online orientation, a generator, upgrades to the HVAC system, and laptops for staff.

1. Dual Enrollment – see attached Presenter: Ms. Marr ET Lead: Ms. Bonilla Dual Enrollment: Matriculation & Modality

Dual enrollment matriculation rates for GFC were 13% in first fall term after graduation and 9% in first spring term after graduation. Dual enrollment by modality (concurrent, on-campus, and online) was shown for AY 16 – AY 21. Fall '20 showed 217 concurrent, 60 on campus, 329 online.

Student Credit Hours showed highest participation for online, then concurrent, then on-campus. Most of our concurrent courses are taught in Class AA schools so the online modality catches rural and home-schooled students.

Participation: we generally have between 50-55 partner agreements, but not all have participating students. The One Two Free program increased participation. There is room for growth within Class A schools.

Key to the success of this program are building relationships with schools and the mindset of administrators/faculty.

GF district generally uses graduate-level honors faculty. What are the opportunities/incentives for faculty to obtain graduate-level work? How can we attract more midrange students who may be more likely to attend GFC?

How do we build relationships through word of mouth in these areas? How else can we get out there? What staff would be effective? What about a "night out" event?

#### 6. Other - GFC fall class enrollment

Online classes are filling up faster than face-to-face classes. Offering Hy-Flex classes should attract students.

Eleven Respiratory Therapy students have applied, evenly split between Great Falls, Billings and several outlying areas. RT Director Melissa Wells toured campus last week.

Dental assisting applicants are low – we will research whether our graduates obtain higher salaries than non-graduates in the workplace. Overall, fall enrollment is up but keep in mind that we opened up later last year.

Several program changes were made that were right for students but decreased our enrollment numbers, such as removing the summer term for Respiratory Therapy and Nursing. ET discussed the possibility of adding an additional later summer term, and whether we should survey students about this possibility. How would this play into Shannon Marr's overall plan?

Programs to watch are Renewable Energy Technician, Accounting, Dental Assisting, and the Computer Tech programs. Discussed the possibility of a computer tech fair to showcase the programming, networking, and cybersecurity programs.



# The Good and the Not-so-good...

## Doing well:

- Statewide: more access for all students due to 1-2-Free and online offerings
- Great Falls College: serving more rural "C" schools than many other colleges
- Good number of concurrent course offerings in large high schools and a few smaller schools
- Getting better at monitoring students during dual enrollment and offering support
- Growth despite COVID and other declining enrollment populations

## **Room for Improvement:**

- Increased access for mid-range students (still primarily serve "A "students because of mixed AP/Dual Credit courses
- Increased access for native and other minority populations
- Preparation, Orientation, and Onboarding support for students and families
- Training for high school teachers, counselors, college faculty
- More advising for good course planning related to Gen Ed core
- Developing career/CTE academies that can provide packages of credit and possible credentials
- Increased matriculation rates—more GFC dual credit students should turn into GFC full time students
