1. LRBP Visit ET Lead – Dr. Stevens

The LRBP visit will be held on September 20. Terry Leist, Tracy Ellig, President Cruzado, and Dan Stevenson from MSU in Bozeman, and Ron Muffick from the Commissioner's Office will be in attendance along with the GFC MSU Executive Team, local legislators, and the Executive Advisory Council.

GFC MSU's request will be for a new dental clinic/lab space. Data from the dental hygiene program and a previous report will be compiled once final numbers are received from the architect. Updated data for the Academic Success Center and the Veterans' Success Center will also be available. Dr. Stevens will meet with Carmen Roberts and Gary Smart to determine space use and costs to refurbish the current dental area.

2. 8-week Course Block ET Lead – Ms. Bonilla

Dr. Wolff met with the Division Directors last Friday at their retreat. She noted that GFC MSU's focus is on quality. The State Worker Demand report showed excellent numbers on how we are supporting our community. The 8-week block schedule does post challenges with student affairs. Ms. Bonilla will provide the Executive Team with information shared last spring in regards to what Student Services will need to make the 8-week block schedule successful, as well as a staffing model for student affairs. It was asked if the students who left after the first 8 weeks ever come back? At this time, it was recommended to be patient to let the new student coach and structured scheduling work. Ms. Bonilla will return with a report on her findings in one year.

4. OneMSU Symposium Student Participation ET Lead – Ms. Jaynes

Ms. Jaynes will send the draft agenda for the November 1-2, 2017 OneMSU Symposium to the Executive Team. This year's event will be held at MSU in Bozeman.

5. No Smoking on Campus Grant ET Lead – Ms. Bonilla
