If your legal parents are living and married to each other, answer the questions about both of them. If your legal parents are not married and live together, answer the questions about both of them. In case of divorce or separation, give information about the parent who provided more financial support during the past 12 months. If your divorced or widowed parent has remarried, also provide information about your stepparent.
