Thank you for your interest in the Veterinary Technician Program at Great Falls College! The design of this program is a distance education model which means all classes including labs and clinicals are done off campus.

A Veterinary Partner serves as your primary learning site, where you will complete hands-on clinical skills under the supervision of a licensed veterinarian or credentialed veterinary technician.

This form is meant to identify your preferred Veterinary Partner sites and indicates that you have contacted each one and confirmed they would be willing to provide support for your education. Part A is due by November 10, 2025. Application Part A will ONLY be received electronically via a completed DocuSign packet. Once submitted a copy will be sent electronically to the Veterinary Technician Admissions Committee.

Submission of Part A does not guarantee or affirm that the listed clinics will be or are approved Veterinary Partners.

You must have an approved Veterinary Partner for your application to the Veterinary Technician Program to be considered.

A letter of approval will be sent to the clinics upon approval by the Veterinary Technician Program and this letter must be submitted as part your Veterinary Technician application Part B.

Before submitting Part B of your application, you must confirm that you have an approved Great Falls College Veterinary Partner.

Because of the Rabies vaccination requirements by the CVTEA (Committee on Veterinary Technician Education and Activities) and the scarcity of exotic veterinary care in Montana, Great Falls College Veterinary Technician program provides an optional Fast-Track lab at Sandy's Haven in Preston, ID for exotic and large animal skills. All travel expenses (transportation and lodging) are the responsibility of the student.
